Registration

Confirmation of Registration

Logistics

WebEx and remote connection links, and related instructions, will be sent by e-mail to each attendee prior to the training seminar. Attendees will connect remotely to a dedicated AutoForm training computer to complete their training seminar exercises, as well as accessing the training scripts from the AutoForm Service Center website. To participate E-Learning from home/office, attendees must have a computer with two monitors to effectively complete the training seminar.

The training seminar will be available only during the scheduled class dates that you are registered for, starting on the first Monday at 8:00AM through the second Friday until 4:00PM. **Attendees must complete all training materials within the two-week period. The training seminar will automatically close at the end of business on the last day of your scheduled training.**

Number of Participants

To ensure the effectiveness of the E-Learning training seminar, the number of participants per course, may be limited. Therefore, we recommend registering as soon as possible in case the training seminar is full, we will try to suggest an alternative date.

Postponement or Cancellation of Training Seminar by Participant

If we receive your written cancellation more than 14 days prior to the E-Learning training start-date, there is no cancellation fee. For cancellations received within 14 days of the E-Learning training start-date, we must charge a cancellation fee of 25% of the E-Learning training Fee. However, if you cannot attend a course for which you have registered, you can substitute another participant from your company (in this case, the Participation Conditions apply to the new participant).

Postponement or Cancellation of Training Seminar by AutoForm
